## What to Expect

## Legislative Lingo

### *Crossover*

The Crossover Date is the actual day when each Chamber is required to send those bills it intends to pass favorably to the Opposite Chamber. Bills received after this date are subject to referral to Rules Committees (Senate Rule 32(c), House Courtesy Date). The Crossover Date is always the 76<sup>th</sup> Day of Session, which is March 24 this year.

### *Third Reading*

Generally, the third reading is the "final" vote on a bill by the full body. This vote usually occurs one or two days after the bill has passed second reading. No amendments may be offered during the third reading deliberations, which must conclude with a recorded roll call vote. Most bills require only a simple majority, one more than half the membership of the body, for passage. Constitutional amendments and emergency legislation require approval by three-fifths of the membership. Third reading passage sends the bill to the opposite chamber for consideration.

**HB 1136 (MC/PG 101-09) Montgomery County – Washington Suburban Sanitary Commission – Financial Oversight Act** - This bill amends the Sanitary District Laws to require the WSSC to file a certified copy of its annual audit and current financial statements each year with the Montgomery County Council AND it authorizes the County Council of Montgomery County to audit and examine the books and records of the Commission under certain circumstances as long as such an audit or examination is without cost to the WSSC. Current law contains these requirements for the Montgomery County Executive, Prince George’s County Executive and the Prince George’s County Council.

**HB 1139 (MC/PG 104-09) Washington Suburban Sanitary Commission – System Development Surcharge - Exemptions** – This bill expands current law regarding the WSSC’s SDC exemptions from *those community based organizations whose “exclusive” use of the property is to provide programs and services to youth* to *those community based organizations whose “primary” use of the property is to provide programs and services to youth*. Additionally, this bill changes the current law’s sunset from 2009 to 2012.

[Bill amended 2/18/09 to strike all changes and extend the sunset to 2010. Amendments result in straight sunset extension.]

[Original bill as introduced re-amended by the Bi-County Subcommittee on 2/25/09 changing “primarily” to “substantially” and adding “recreational and educational” to the description of programs eligible for this exemption.”]

**HB 1137 (MC/PG 105-09) Washington Suburban Sanitary Commission – Budget Approval** - This bill provides that if the county councils of Montgomery and Prince George’s Counties fail to concur on the WSSC capital budget or any provision within the capital budget by a certain time, the funding levels may not exceed the previous year’s funding levels. The bill includes language that allows a single line item to be rejected for any single capital budget project, similar to a line item veto. The WSSC believes this bill would have a negative impact on the Agency should it become law for several reasons. First, the construction industry may find it problematic to bid under such uncertainty. If projects were cancelled, vetoed, or financially constrained after awarded, it would be costly to the WSSC and the ratepayers. Additionally, projects including MBE and SLBE subcontractors could potentially be delayed, creating a detrimental impact on these businesses. Second, there could be a negative impact on facilities included in the 30 Year Infrastructure Plan to recapitalize the WSSC’s aging infrastructure. Third, the WSSC AAA Bond Rating would be in jeopardy given the importance rating agencies place on governance of public entities in their rating criteria. Finally, the WSSC could face IRS penalties if the Agency’s ability to spend bond money in a timely manner was hampered and arbitrage rules broken.

**HB 1145 (MC/PG 118-09) Washington Suburban Sanitary Commission – Membership – (late filed bill)**

This bill alters the current WSSC Commission board by adding a 7<sup>th</sup> Commissioner whose appointment shall alternate between the governing bodies of the municipal corporations that contain the largest number of housing units served by the WSSC in Montgomery and Prince George's Counties. Each municipal appointment shall be a registered voter. These new appointments do not require confirmation by the County Councils, as County Executive appointments do. The municipal appointment term will also be for 4 years beginning on June 1, 2009.

**HB 1133 (MC/PG 120-09) Washington Suburban Sanitary Commission – Comprehensive Whistleblower Protections – (late filed bill)** This bill extends state employee whistleblower protections to WSSC employees. Requires the Commission adopt regulations similar to those found in the State Personnel and Pensions Article. Include prohibiting a manager or supervisor from taking or refusing to take a personnel action as a reprisal against an employee who discloses instances of abuse of authority, gross mismanagement, gross waste of money, substantial and specific danger to public health or safety, or any violation of the law. Requires the Commission to provide employees with written notice of protections and remedies provided by regulations. Enactment date October 1, 2009. The regulations would have to be adopted on or before October 1, 2010.
