MINUTES OF THE COMMISSION MEETING

Monday, August 31, 2015  
Bethesda, Maryland

Chair Adrienne A. Mandel called the meeting to order at 9:30 a.m. in the Cabin John Room of the Bethesda North Marriott Hotel and Conference Center, 5701 Marinelli Road, North Bethesda, Maryland, with due notice having been given to all members of the Commission and the public. In addition to Chair Mandel, Commissioners Chris Lawson, (Vice Chair), Fausto R. Bayonet, Omar M. Boulware, Roscoe M.
