MINUTES OF THE COMMISSION MEETING

Tuesday, September 11, 2018 Laurel, Maryland

Chair T. Eloise Foster called the meeting to order at 2:10 p.m., in the Commission Office Large Conference Room of the Washington Suburban Sanitary Commission (hereinafter "WSSC") Richard G.

Hocevar ("RGH") Building, 14501 Sweitzer Lane, Laurel, Maryland, 20707, with due notice having been given to all members of the Commission and the public. In addition to Chair Foster,

Commissioners Fausto R. Bayonet, Omar M. Boulware, Howard A.

Denis, Chris Lawson and Thomasina V. Rogers, were present at the meeting, reflecting the presence of a quorum. Also in attendance were WSSC Corporate Secretary Sheila R. Finlayson, Esq., who recorded the minutes of the meeting and Gregg Moser of the Executive Search Firm of Krauthamer & Associates, Inc., engaged by the Commission to assist with the Inspector General Recruitment.

OPEN SESSION

The Chair opened the meeting by calling for a moment of silence in observance of the tragedy that transpired in New York,

Pennsylvania and Virginia on September 11, 2001.

The Chair then stated the purpose of the meeting, as follows:

"to conduct interviews of candidates recommended by the Inspector

General Appointment Committee for the current WSSC Inspector

General (IG) Recruitment. The WSSC Office of the Inspector

General was established in 2018 by the Maryland General Assembly

with October 1, 2018 as its effective date of operation. The Act

requires the Commission to select the WSSC Inspector General from

the Appointment Committee's list of recommended candidates.

The Appointment Committee, consisting of one Commissioner from Montgomery County (Howard Denis), one Commissioner from Prince George's County (Thomasina Rogers), one member of the public selected by the Montgomery County Council (Benjamin Smith) and one member of the public selected by the Prince George's County

Council (Turkessa Green), met on August 22, 2018 to review candidates sourced by the search firm of Krauthamer & Associates, engaged by the Commission to assist with the IG recruitment.

The Committee interviewed six candidates on September 7, 2018 and has recommended four candidates for the Commission's consideration. The law requires that the Committee prepare and submit to the Commission an initial list of at least three and not more than six candidates to recommend for appointment as Inspector General. The Committee submitted its recommended list to the Commission and the Commission will interview one candidate during this closed meeting today and will convene another special meeting tomorrow, September 12, 2018, at 11:30 a.m., to interview the remaining three recommended candidates."

AGENDA APPROVAL

Commissioner Lawson moved to adopt the Special Commission Meeting Agenda of September 11, 2018, as drafted, to which Commissioner Rogers seconded the motion. The motion carried unanimously with six affirmative votes.

CLOSED SESSION

Commissioner Rogers moved that the Commission go into Closed

Session pursuant to Maryland Code Annotated, General Provisions

Article: Section 3-305(b)(1), to discuss personnel matters

related to the Inspector General Recruitment.

Commissioner Denis seconded the motion. The motion carried unanimously with six affirmative votes.

At 2:15 p.m., Chair Foster declared the meeting was Closed.
