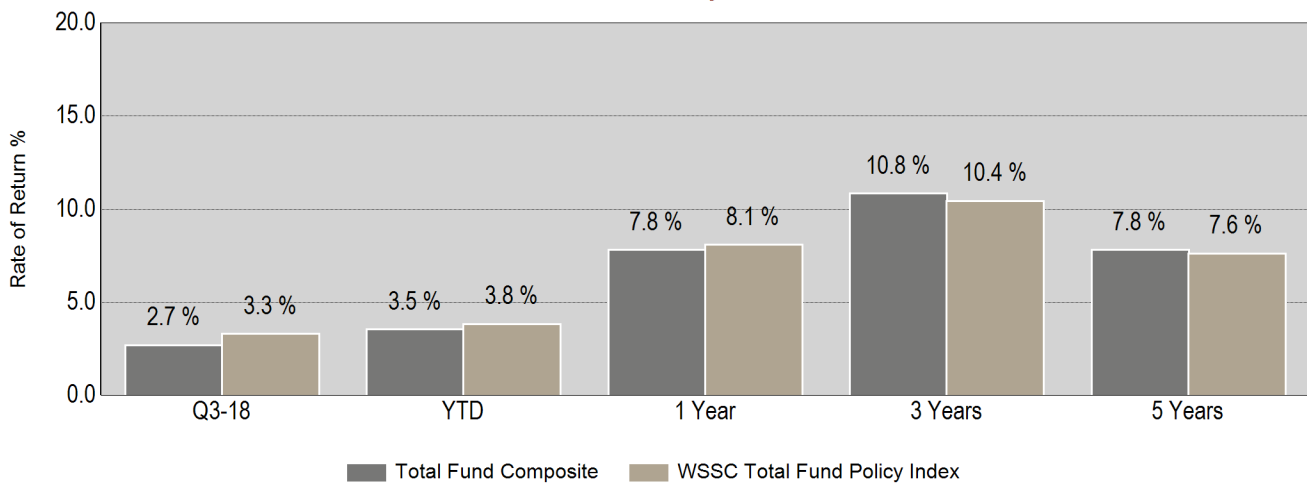

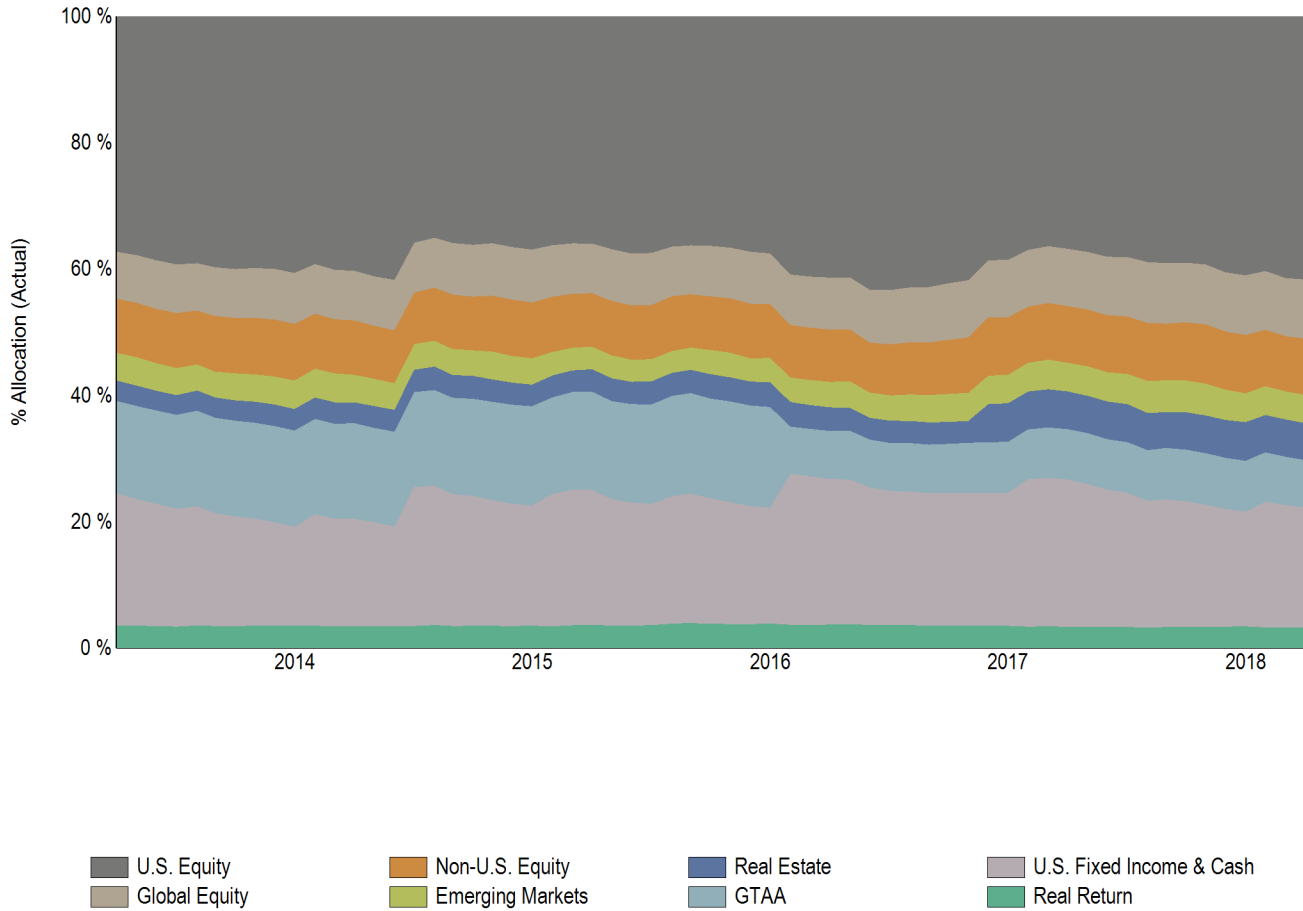

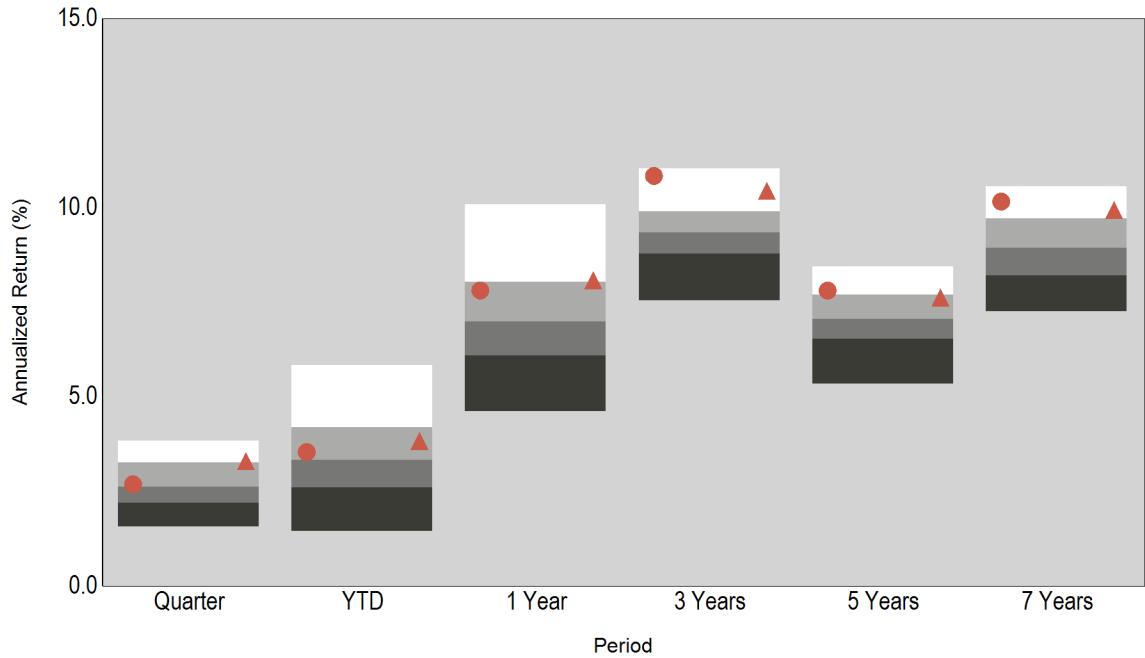

5 Years Ending September 30, 2018

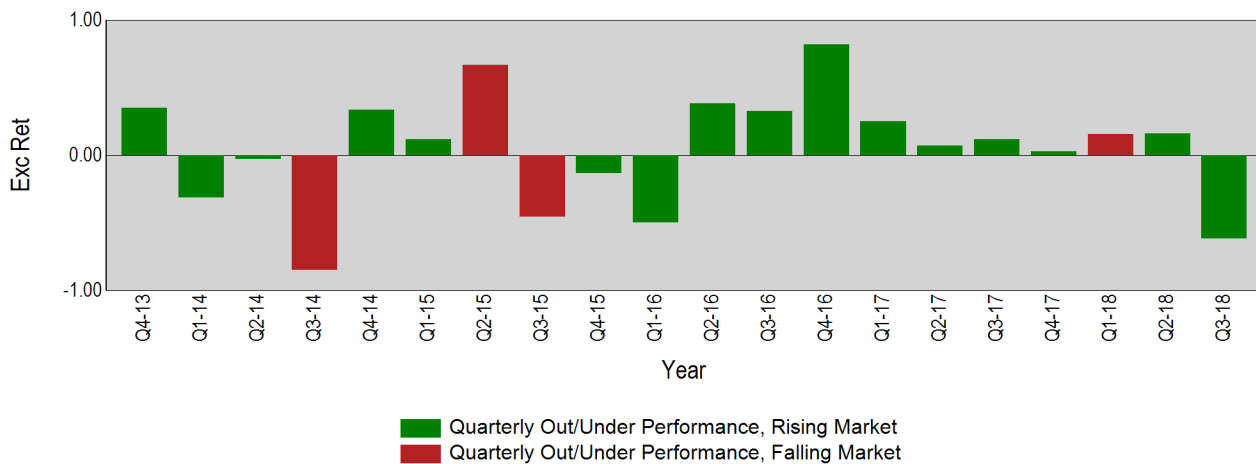

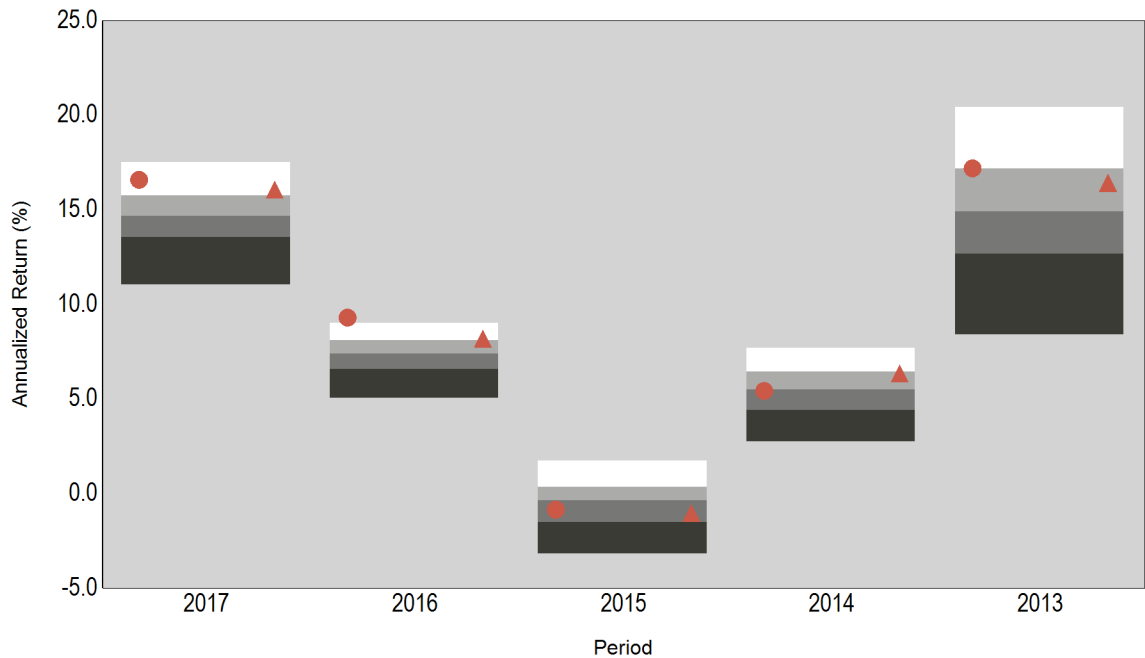
