- SEWAGE DISCHARGING ONTO A GRASSY AREA, ENTERING A STORM DRAIN RETENTION POND AT THE PUMPING STATION IN THE LOWER ANACOSTIA BASIN. UPON ARRIVAL, THE CREW FOUND MANHOLE #122M OVERFLOWING. THE MAINLINE RELIEVED ITSELF AT 11:49AM, ENDING THE EVENT.
- IMPACTS UPON PUBLIC HEALTH AND STATE WATERS: DISCOLORATION DRY WEATHER PUBLIC ACCESS PUBLIC USE OBSERVED
- STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE: UPDATE 05/03/2018 - UPON FURTHER INVESTIGATION, WSSC HAS DETERMINED THIS SANITARY SEWER OVERFLOW WAS CAUSED BY ONGOING CONSTRUCTION ACTIVITIES ON A SEWER RECONSTRUCTION PROJECT. THE ONGOING CONSTRUCTION ACTIVITIES RESULTED IN DAMAGE TO A WATER MAIN, CAUSING IT TO BREAK, SENDING A LARGE AMOUNT OF WATER AND DEBRIS DOWN THE SEWER LINE.
- MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT: GRADING OF AREA

THE CREW PUT DOWN SIX BALES OF HAY. NO LIME WAS SPREAD DUE TO THE RUN OFF ENTERING A STORM DRAIN RETENTION POND AT THE HYATTSVILLE WASTEWATER PUMPING STATION.
