CAUSE: ROOTS & GREASE EST OVERFLOW VOLUME: UPON THE CREW'S ARRIVAL, MANHOLE 056M WAS OVERFLOWING APPROXIMATELY 7 GALLONS PER MINUTE INTO A NEARBY STORM DRAIN, IN THE NORTHWEST BRANCH BASIN. THE CREW JETTED FROM MANHOLE 055U TO MANHOLE 056M, A TOTAL OF 350 FEET, RELIEVING A HEAVY GREASE, RAGS, AND ROOTS OBSTRUCTION AT 349 FEET; ENDING THE OVERFLOW.
