CAUSE: DEFECTIVE MATERIAL EST OVERFLOW VOLUME: 4,230 GAL UPON ARRIVAL, THE INSPECTOR FOUND MANHOLE #028U OVERFLOWING 5 GALLONS PER MINUTE, ENTERING A NEARBY CREEK IN THE PISCATAWAY CREEK BASIN. THE CREW JETTED FROM MANHOLE #027U TO MANHOLE #028U, AND WERE UNABLE TO RELIEVE AN UNKNOWN BLOCKAGE. A WSSC WATER CONTRACTOR SET UP OVERPUMPING, ENDING THE EVENT.

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE:

THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE
ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUCTED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE
THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

ON 08/03/2020, A VIDEO INSPECTION REVEALED AN APPARENT LINER FAILURE AT 231 FEET UPSTREAM FROM MANHOLE #027U.

OVERPUMPING WILL REMAIN IN PLACE UNTIL THE LINER IS REPAIRED. A CCTV INSPECTION WILL BE PERFORMED AFTER THE REPAIRS.

09/08/2020 UPDATE - THE REPAIRS WERE COMPLETED ON 08/21/2020.

OVERPUMPING HAS BEEN REMOVED. A CCTV INSPECTION HAS BEEN PERFORMED.
