ACTION REQUESTED:

Purpose of this Commission Package: To request approval to award Contract No. 16731 Pre-stressed Concrete Cylinder Pipe (PCCP) Engineering Services to two (2) contractors: Black & Veatch Corporation and HDR Engineering, Inc. The contract has a base term of three (3) years for a not to exceed amount of \$4,500,000.00 each and one (1) two-year option term with an amount not to exceed \$3,000,000.00 each. The total amount requested for approval is \$15,000,000.00.

Basis of Award: This solicitation is being awarded to the firms deemed as the most advantageous to WSSC Water, taking into consideration the evaluation factors set forth in the Request for Proposals.

PROJECT OVERVIEW:

The scope of this contract includes providing engineering services to support the Commission's Pre-stressed Concrete Cylinder Pipe (PCCP) management program. The services include, but are not be limited to, the following: internal visual and sounding pipeline inspection, sonic/ultrasonic pulse echo testing, pipeline Right-of-Way assessment, development of finite element analysis curves, leak detection, wall thickness testing for metallic mains, PCCP forensics dissection, permit acquisition, geotechnical investigation, traffic control, topside support for confined space entry, coordination, planning and engineering services needed to support inspections provided by the Consultant, and special studies related to the management of the Commission's PCCP network on an as needed basis.

The Office of Supplier Diversity & Inclusion ("OSDI") has reviewed the request for Award of Contract No. 16731 PCCP Engineering Services. In accordance with MBE Program Regulation (WSSC Water Code of Regulations Chapter 6.30) and SLBE Program Regulation (WSSC Water Code of Regulations Chapter 6.35), this solicitation was advertised with a 22.00% Minority Business Enterprise and Small Local Business Enterprise (MBE/SLBE) subcontracting requirement that can only be satisfied by WSSC Water-Approved SLBEs (SLBE only or SLBE-SDVs) and the following qualified and certified-MBE firms: African American, Asian American, Hispanic American and Female/Women-Owned.

This Solicitation was advertised in WSSC Water's Supplier Portal System and through the Commission's normal procurement process. An Evaluation Committee was established with defined evaluation criteria. Five hundred sixty sixty-four (564) firms were notified, one-hundred twenty-three (123) firms downloaded the solicitation and two (2) proposals were received.

Black and Veatch, a majority-owned firm located in Gaithersburg, Maryland and HDR Engineering, Inc., a majority-owned firm located in Chicago, Illinois are the recommended Awardees by the Procurement Office. The contract has a base term of three years with one (1) two-year option term. The contract value for the base term is \$4,500,000.00 for each awardee.
