This contract was approved by the Commissioners on June 20, 2018 with a base term of three (3) years in the amount of \$10,003,998.33.

The Office of Supplier Diversity & Inclusion (OSDI) has reviewed the request for Concurrence with Option Term One (1) for Contract No. 7335 Various Water Meter Replacements. In accordance with MBE Program Regulations (WSSC Water Code of Regulations Chapter 6.30) and SLBE Program Regulations (WSSC Water Code of Regulations Chapter 6.35), this contract was awarded to the following firms: Tricon Chemical Corporation, a certified-MBE (MDOT #85-089, African American) firm located in Forestville, Maryland – Groups 2, 3 and 5 for a contract value of \$3,700,924.50; Master Meter Inc., a majority-owned firm located in Mansfield, Texas – Group 6 for a contract value of \$1,431,811.83; Fasteners RX Inc., a certified-MBE (MDOT #05-124 Female/Woman-Owned) firm located in Chester, Maryland – Group 1 for a contract value of \$4,370,412.00; and Reviera Enterprises Inc., a certified-MBE (MDOT #93-080, African American) firm located in Forestville, Maryland – Group 4 for a contract value of \$500,850.00. The contract had a three- (3) year Base-Term with one (1) two-year Option Term.

The Base Term for Contract No. 7335 (102513/102514/102518/102519) commenced on July 11, 2018 and will expire on July 10, 2021.

To date, according to WSSC Water's Web-Based Compliance System, Tricon Chemical Corporation (102514) has been paid \$572,102.87; Master Meter, Inc. (102518) has been paid \$908,240.80; Fasteners RX, Inc. (102513) has been paid \$3,060,146.24; and Reviera Enterprises, Inc. (102519) has been paid \$909,495.30.

Option Term One (1) will commence on July 11, 2021 and will expire on July 10, 2023. The contract value for Option Term One (1) for each firm is as follows: Tricon Chemical Corporation, \$500,000.00; Master Meter, Inc., \$572,725.00; Fasteners RX, Inc., \$1,154,600.00 and Reviera Enterprises, \$794,000.00. The total contract value for Option Term One (1) is \$3,021,325.00.
