UPON ARRIVAL, THE CREW FOUND MANHOLE #029M OVERFLOWING 10GPM INTO A
CREEK IN THE NORTHWEST BRANCH BASIN. THE CREWS HAND RODDED FROM MH010U
FOR 90 FEET AND PARTIALLY RELIEVED HEAVY RAGS AND GREASE, REDUCING
THE VOLUME TO 5GPM. THE CREWS RETURNED AND HAND RODDED MH010U TO 029M
FOR 120 FEET, RELIEVING HEAVY RAGS AND WIPES TO END THE EVENT.
