CAUSE: ROOTS EST OVERFLOW VOLUME: 786 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 395U OVERFLOWING APPROXIMATELY 5 GALLONS PER MINUTE GOING INTO A NEARBY CREEK. THE CREW JETTED THE MAINLINE FROM MANHOLE 011U TO MANHOLE 395U AND RELIEVED ROOTS, RAGS

AND GREASE AT 205 FEET, ENDING THE EVENT.
