CAUSE: ROOTS AND WIPES EST OVERFLOW VOLUME: 229 GAL UPON ARRIVAL THE CREW FOUND MANHOLE 003U OVERFLOWING AT A RATE OF 3GPM INTO A NEARBY STORM DRAIN; IN THE PARKWAY BRANCH BASIN. THE CREW JETTED FROM MANHOLE 002M TO 003U A TOTAL OF 158', AND HIT AND RELIEVED HEAVY WIPES AND ROOTS IN MANHOLE 003U; ENDING THE EVENT.
