UPON ARRIVAL, THE CREW FOUND BROKEN SEWER PIPE AT 5 FEET DOWNSTREAM OF MANHOLE 07065010M, LEAKING INTO AN ADJACENT POND AT APPROXIMATELY 1 GALLON PER MINUTE.A WSSC CONTRACTOR SET UP OVERPUMPING FROM MH# 07065010M TO MH# 07065008U TO END THE EVENT.

IMPACTS UPON PUBLIC HEALTH AND STATE WATERS:

DRY WEATHER PUBLIC ACCESS

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE:

THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUCTED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT:

OVERFLOW IN POND DILUTED DUE TO RAIN AFTER THE EVENT. OVERPUMPING TO STAY IN PLACE UNTIL WSSC CONTRACTOR PERFORM REPAIR ON THE BROKEN PIPE.
