#### **OPEN SESSION MINUTES**

Wednesday, June 8, 2022 Laurel, Maryland

The Board of Ethics ("Board") met via videoconference to conduct an Open Session pursuant to Maryland Code Annotated, General Provisions Article § 3-305(b)(13).

Chair George Pruden called the meeting to order at 1:03 p.m. with the following members present:

# **Open Session**

**Approval of Open Session Minutes – May 11, 2022** 

The Board reviewed the draft Open Session Minutes from the May 11, 2022 meeting.

On motion of Dr. Hausman and seconded by Mr. Hysen, three members of the Board (Hausman, Hysen, and Pruden) voted to approve the May Open Session Minutes.

## **Matters of Discussion**

#### **Ethics Program Monthly Report**

Ms. Dorsey White provided an update on the activities in the Ethics Office for May 2022. She reported that she provided ethics training to 25 new employees as part of the onboarding process. Dr. Hausman asked if the onboarding of 25 employees is higher than normal. Ms. Dorsey White replied that there were 3 sessions which account for the higher number.

Ms. Dorsey White also shared that the Ethics Office provided guidance on 23 matters, of which the leading categories were Disclosure Statements and Outside Employment / Interests.

Ms. Dorsey White stated that the Ethics Spotlight topic she will present at the June 15, 2022 Commission meeting will be "Politics & H<sub>2</sub>O People", focusing specifically on policies related to political activity and campaign paraphernalia. Dr. Hausman stated that it would be useful to repeat this topic in the fall during the elections. Ms. Slaughter added that it would also be beneficial to explicitly state that employees should not use WSSC email for any election activities.

#### **Financial Disclosure Update**

Ms. Dorsey White provided an update on the status of the annual financial disclosure process. She explained that the vendor was unable to resolve the issue with the original financial disclosure form so a new form was created and

relaunched on June 1, 2022. Staff have been informed that the due date for completion is June 30, 2022. Except for questions about how to complete the forms, Ms. Dorsey White shared that there have not been any technical issues reported. Chair Pruden asked how many financial disclosures had been filed to date. Ms. Dorsey White replied that approximately 500 were in progress.
