UPON ARRIVAL, THE CREW FOUND MANHOLES 075M AND 074M OVERFLOWING AT A COMBINED RATE OF APPROXIMATELY 2 GPM, ENTERING A STORM DRAIN, IN THE BEAVERDAM BRANCH BASIN. THE CREW JETTED FROM MANHOLE 074M TO 010U, A TOTAL OF 333FT, AND RELIEVED GREASE AT 165FT TO END THE EVENT.

FLUSHED BACK INTO MANHOLE VISIBLE SOLIDS REMOVED

VISIBLE SOLIDS WERE REMOVED FROM THE SITE, AND LIQUID WAS FLUSHED BACK INTO AN ADJACENT MANHOLE.
