UPON THE CREWS ARRIVAL, MANHOLE 229M WAS OVERFLOWING AT APPROXIMATELY  
5GPM. THE CREW JETTED FROM MANHOLE 228U TO 229M, A TOTAL OF 108FT,  
AND RELIEVED A HEAVY GREASE AND WIPES OBSTRUCTION AT 80FT; ENDING  
THE OVERFLOW.
