CAUSE: ROOTS & GREASE EST OVERFLOW VOLUME: 684 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 026U WAS OVERFLOWING AT APPROXIMATELY 2GPM INTO A NEARBY POND, IN THE PAINT BRANCH BASIN. THE CREW JETTED FROM MANHOLE 289U TO 026U, A TOTAL OF 343 FEET, AND RELIEVED HEAVY ROOTS AND GREASE AT 200 FEET TO END THE EVENT.

NEARBY BIKE TRAIL WAS AFFECTED DUE TO OVERFLOWING SEWER FROM MANHOLE.

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE: THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUC-TED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT: LIME

THE CREW RESTORED THE AFFECTED AREA AND SPREAD LIME TO TREAT IMPACTED GROUND. ALSO, THE CREW CLEANED UP THE AFFECTED BIKE TRAIL AND TREATED IT WITH LIME.
