CAUSE: ROOTS EST OVERFLOW VOLUME: 116 GAL
UPON ARRIVAL, THE CREW FOUND MANHOLE 004M OVERFLOWING APPROXIMATELY 1GPM INTO A GRASSY AREA AND A NEARBY STORM DRAIN IN THE CABIN JOHN BASIN. THE CREW JETTED FROM MANHOLE 003M TO 004M, A TOTAL OF 306FT, AND HIT AND RELIEVED A HEAVY ROOT OBSTRUCTION AT 130FT, ENDING THE EVENT.

IMPACTS UPON PUBLIC HEALTH AND STATE WATERS:
DRY WEATHER NOTICEABLE ODOR

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE:
THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUCTED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

LIME

THE CREW POSTED 10 SIGNS FROM MANHOLE 004M TO THE CLARA BARTON PARKWAY. THE CREW SPREAD LIME IN THE GRASSY AREA AROUND THE MANHOLE.
