UPON ARRIVAL, THE CREW FOUND MANHOLE 015U OVERFLOWING APPROXIMATELY 2 GPM INTO THE GRASSY AREA AROUND THE MANHOLE. MANHOLE 017M AND 016M WERE ALSO HOLDING. THE CREW JETTED FROM MANHOLE 015U TO MANHOLE 004M A TOTAL 371 FEET, AND HIT AND RELIEVED ROOTS, WIPES AND LIGHT GREASE AT 362 FEET, ENDING THE EVENT.
