CAUSE: GREASE AND WIPES EST OVERFLOW VOLUME: 906 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 733N OVERFLOWING APPROXIMATELY 5 GPM INTO THE GRASSY AREA AROUND THE MANHOLE AND INTO A NEARBY STORM DRAIN THAT ENTERS NORTHEAST BRANCH. THE CREW JETTED FROM MANHOLE 694M TO MANHOLE 721U, A TOTAL OF 135', AND HIT AND RELIEVED A HEAVY GREASE AND WIPES BLOCKAGE AT 134', ENDING THE EVENT.
