CAUSE: ROOTS & GREASE EST OVERFLOW VOLUME: 173 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 185M OVERFLOWING APPROXIMATELY 1 GPM, GOING INTO THE GRASSY AREA AROUND THE MANHOLE AND ENTERING A NEARBY STORM DRAIN THAT OUTFALLS IN PISCATAWAY CREEK. THE CREW JETTED FROM MANHOLE 183M TO 185M, AND HIT AND RELIEVED HEAVY GREASE AND ROOTS AT 251FT, ENDING THE EVENT.
