

Allentown Road Project: 90% Complete, On Schedule

- Began: March 2022
- Estimated Completion: Late Fall 2024
- Replacing 3.57 miles of water mains ranging from 4-inch to 42-inch diameter
- Enhance system resilience and redundancy
- Final paving and striping: Spring 2025, weather permitting



Allentown Road Final Paving



Impacted Streets

- Allentown Road between Old Branch Avenue and Temple Hill Road

Old Branch Avenue Project: 85% Complete, On Schedule

- Began: March 2022
- Estimated Completion: Summer 2025
- Installing three miles of new 30-inch-diameter water transmission main
- Significantly increase flow from the Potomac Water Filtration Plant to southern Prince George's County.
- Final paving and striping: Summer 2025


Upcoming Traffic Impacts & Road Closures



Location	Estimated Duration
8000 Old Branch Ave. block	5 weeks
7100 Old Branch Ave. block	2 weeks
Kirby Rd. exit ramp from Rt. 5	3 weeks
Between Aley Rd. and 6705 Old Branch Ave.	2 weeks

This schedule is estimated and weather dependent.

Impacted Streets

- Old Branch Avenue between Allentown Road and Woodyard Road/Piscataway Road

We Made Changes Thanks to Your Input

New paving procedures:

- Final paving and striping in phases, when possible.
- Replace temporary patches with permanent ASAP.
- Daily inspections of temporary patches and steel plates.
- Corrections made before contractor leaves job site.



Pedestrian Safety is Paramount

- Warn pedestrians when sidewalks are closed.
- Ensure all sidewalk patches are smooth and level.
- Enhance safety and visibility around above ground pipes.





Coordination & Communication

- Prince George's County DPW&T
- Underground work completed prior to final paving and restoration.
- Address customer concerns



Helping Our Neighbors: Water Bill Assistance



Promise.

Sign up for an affordable, flexible and interest-free payment plan. **Customers with a past-due balance of \$50 or more are eligible.**



CUSTOMER ASSISTANCE PROGRAM (CAP)

CAP assists approved residential customers by **waiving fixed fees**, providing **free annual plumbing inspections** for water leaks and **much more.**



WATER FUND

Sharing the Essential

Eligible customers can access the Water Fund multiple times, **up to \$500 per year.**



PipeER+

Provides a loan of **up to \$10,000** to finance the repair, replacement or diagnostics of sewer or water on-property service line. The WSSC Federal Credit Union administers PipeER.
