UPON ARRIVAL, THE CREW FOUND MANHOLES 010U AND 009M, OVERFLOWING APPROXIMATELY 5GPM, ONTO THE GRASSY AREA AROUND MANHOLE 009M, AND INTO A NEARBY CREEK IN THE BROAD CREEK BASIN. THE CREW JETTED FROM MANHOLE 007M TO 008U, A TOTAL OF 47', AND HIT AND RELIEVED A HEAVY GREASE AND WIPES OBSTRUCTION, TO END THE EVENT.
