UPON ARRIVAL, THE CREW FOUND MANHOLE 008M OVERFLOWING AT 2GPM, INTO A NEARBY STORM DRAIN THAT OUTFALLS INTO BEAVERDAM BRANCH. THE CREW RELIEVED HEAVY WIPES AND SANITARY NAPKINS FROM MANHOLE 007M, TO END THE EVENT.

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE:

THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUCTED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT:

FLUSHED BACK INTO MANHOLE

THE CREW WASHED DOWN THE AREA AROUND THE MAHHOLE WITH DECHLORINATED WATER.
