UPON ARRIVAL, THE CREW FOUND MANHOLE 075M OVERFLOWING 10 GPM, ONTO THE PAVEMENT, AND INTO A NEAR BY STORM DRAIN THAT ENTERS SLIGO CREEK BASIN. THE CREW JETTED FROM MANHOLE 084U TO 075M, A TOTAL OF 95', AND HIT AND RELIEVED DEBRIS AT 95', TO END THE EVENT.
