UPON ARRIVAL, THE CREW FOUND MANHOLE 058M OVERFLOWING APPROXIMATELY 2GPM, ONTO THE GRASSY AREA AROUND THE MANHOLE, AND INTO A NEARBY WATER WAY THAT OUTFALLS INTO NORTHWEST BRANCH. THE CREW JETTED FROM MANHOLE 008U TO 058M, A TOTAL OF 198FT, AND HIT AND RELIEVED ROOTS AND GREASE AT 190FT, TO END TH EVENT.
