CAUSE: SEWER REPAIR

UPON NOTICE OF ELEVATED FLOW METER READINGS, A WSSC PROJECT MANAGER
DISPATCHED A CONTRACTOR TO INVESTIGATE. UPON ARRIVAL, THE CONTRACTOR
FOUND MANHOLE 012M BACKED UP. WHILE SETTING UP BYPASS PUMPING
OPERATIONS, THE CONTRACTOR'S EQUIPMENT CAUSED A SINKHOLE TO FORM BELOW
MANHOLE 010M, RESULTING IN A MAINLINE FAILURE AND A SEWAGE OVERFLOW OF
APPROXIMATELY 3 GPM ONTO THE GRASSY AREA AND INTO A NEARBY TRIBUTARY THAT
OUTFALLS INTO ROCK CREEK. THE CONTRACTOR THEN RECONFIGURED THE BYPASS FROM
MANHOLES 011U AND 211M TO MANHOLE 008M, TO END THE EVENT.

IMPACTS UPON PUBLIC HEALTH AND STATE WATERS: DRY WEATHER

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE:
WSSC CONTRACTOR ARE SCHEDULED TO REPAIR THE PIPE. A FOLLOW-UP
INVESTIGATION WILL BE CONDUC-TED TO DETERMINE WHAT MEASURES SHOULD BE
TAKEN TO REDUCE OR ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING
AGAIN.

MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT:

THE CREW SPREAD LIME IN THE GRASSY AREA AROUND THE MANHOLE.
