

Avenel Property History

- WSSC Water bought 395 acres from Rock Run developer in 1988 to construct an Advanced Wastewater Treatment (AWT) Plant
- WSSC Water conveyed 225 acres to PGA/TPC at Avenel for golf course development
- The original plan for WSSC Water's 170 acres, which includes the land on which the barn sits, was for an AWT Plant
- TPC golf course and WSSC Water-owned land was intended to create a buffer between the plant and the community

Avenel Property Current Uses

- Public ballfields/recreational areas at no cost to the community
- Environmentally protected land, which was swapped with land used for Avenel Swim and Tennis Club
- Avenel HOA landscaping storage, at no cost to the community
- TPC driving range/access roads/land to support the PGA golf tournament
- Monopole provided to cellular carriers
- Equestrian trails, temporary barns for Ms.
 Evans' horses

The RFI Approach

Market Research Tool

Gathers information about available solutions, capabilities and market conditions

Vendor Identification

Identifies qualified contractors and service providers in specialized industries

Informed Decision-Making

Improves procurement outcomes by understanding market capacity and technical feasibility



No Commitment Required

Information gathering only, no obligation to proceed with any respondent

Improved Procurement Strategy

Informs future RFP/RFQ development with market insights

Industry Engagement

Builds relationships with potential future partners

Transparency

Demonstrates due diligence and open, competitive process

The Process

RFI Details:

- Equestrian Center Management Services
 - Qualified operators for comprehensive facility management
- Barn Facilities Rehabilitation/Rebuilding
 - Contractors for stable, riding rings and facility construction/renovation

Marketing:

- Industry Publications.
 - The Horse of Delaware Valley (online)
 - The Equiery (print/online)
- Normal solicitation channels via Procurement
 Office and Office of Supplier Diversity & Inclusion

The Results

Formal

- Equestrian Center Management Services RFI
 - 2 responses through WSSC Water Procurement Portal
- Barn Facilities Rehabilitation/Rebuilding RFI
 - 2 responses through WSSC Water Procurement Portal

Informal

- 2 informal responses not through WSSC Water Procurement Portal
 - Community advocate provided extensive feedback on industry best practices
 - Individual expressed fundraising interest

Key Takeaways

Equestrian Center Management Services


- Detailed responses came from qualified candidates with relevant experience
- Market for these services is limited but includes capable vendors
- Responses did not articulate concrete strategies for securing capital to fund major improvements
- One respondent recommended a market analysis to assess demand, fees and funding opportunities

Barn Facilities Rehabilitation/Rebuilding

- Structural rehab/rebuild responses were strong
- Industry and vendors appear experienced and capable of addressing future needs, if any




Maintaining Safety & Equine Presence at Avenel

 At Gannett Fleming's recommendation, access to the barn has been restricted and fencing around its perimeter remains in place

 Installed five-stall barn and hay storage container on site to accommodate Ms. Evans' horses

 Extended License Agreement with Ms. Evans through December 1, 2025, free of charge





WSSC Water conducted an assessment of future operational needs for the Avenel Property



Reviewed the barn assessment conducted at the community's request



Provided RFI responses to the Avenel Community Association and Montgomery County



Began meeting with community stakeholders and Montgomery County



Discussed potential options with partners including the Montgomery County Revenue Authority

Feasibility Study

Planning level feasibility assessment of the Avenel property for four utilityrelated uses over the next 20 years:

- Water Treatment Facilities
- Wastewater Treatment Facilities
- Drinking Water Storage Facilities
- Maintenance Depot

Assessment considered:

 Future system demands, operational needs, geography, logistics and land use.

Feasibility Study Results

Assessors determined that none of the potential operational needs was feasible at the Avenel Site

No wastewater treatment plant or other water utility use is feasible at this time

Community Takeaways



No future Advanced Wastewater Treatment Plant

Site does not appear technically viable for WSSC Water Operations



Next steps for the property are being evaluated



Meeting with community stakeholders and Montgomery County will continue
