CAUSE: ROOTS EST OVERFLOW VOLUME: 95 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 309M AND 310M OVERFLOWING AT 0.5GPM, ONTO THE GRASSY AREA AROUND THE MANHOLE, AND INTO A TRIBUTARY OF PAINT BRANCH BASIN. THE CREW JETTED FROM 008U TO 310M A TOATL OF 272', AND HIT AND REMOVED A HARD ROOT BLOCKAGE AT 190', TO END THE EVENT.

IMPACTS UPON PUBLIC HEALTH AND STATE WATERS:
