CAUSE: STREAM EROSION EST OVERFLOW VOLUME: 268 GAL UPON ARRIVAL, THE CREW FOUND A SLIGHT WEEPER 10' UPSTREAM FROM MANHOLE 409U, LEAKING ONTO THE GRASSY AREA AROUND THE MANHOLE. A WSSC MAINTENANCE CREW APPLED A PATCH OF QUICK-CONCRETE AROUND THE BROKEN SECTION, TO END THE EVENT.

IMPACTS UPON PUBLIC HEALTH AND STATE WATERS: DRY WEATHER DISCOLORATION NOTICEABLE ODOR

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE: THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUCTED TO WHAT MEASURES SHOULD BE TAKEN TO REDUCE ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT: LIME

THE CREW SPREAD LIME IN THE GRASSY AREA AROUND THE MANHOLE.
