Message from the Commission Chair Mark J. Smith

On behalf of my fellow Commissioners, I'm proud to present WSSC Water's Office of Supplier Diversity & Inclusion (OSDI) Fiscal Year 2025 Performance Report. This report reflects more than just numbers - it highlights our ongoing commitment to creating real opportunities for small, local, and underrepresented businesses.

When I became Commission Chair in June, I identified four top priorities: affordability, outstanding service, ensuring a strong safety record and continuing to invest in critical infrastructure. Our support for small and underrepresented businesses flows through each of these priorities.

One clear example: the recent opening of our newly expanded, technologically advanced \$38 million water quality laboratory. Beyond safeguarding every sip, this project supported 350 jobs — proof again that investing in water infrastructure works for our local economy. On top of that, five Minority Business Enterprise (MBE) firms played key roles in the project, contributing to an MBE utilization rate of 20.52 percent, exceeding our target and delivering \$5.6 million in contracts to small business partners. And these good-paying jobs support both the County Executives' and Councils' efforts to grow our economy.

But at WSSC Water, we are not congratulating ourselves on past successes. We are constantly working to improve pathways to greater opportunities for our business partners. OSDI is driving this transformation by simplifying Small Local Business Enterprise (SLBE) processes, providing training, and expanding outreach to empower local firms to compete for WSSC Water contracts. Our team is building a stronger, more resilient supplier pipeline from forecasting and partnerships to direct engagement. Our Tap into Business events are an outstanding way for small, local, and underrepresented businesses to connect with and ask questions of the OSDI team; to understand what it takes to do business with Maryland's largest utility.

Thank you for your ongoing support of WSSC Water. I'm proud of what we've achieved together and I'm even more excited about what is yet to come.

Throughout the pages of our Office of Supplier Diversity & Inclusion (OSDI) Fiscal Year 2025 Performance Report, you'll discover that WSSC Water has impact work beyond our core mission. Our work not only protects public health and safeguards the environment, but we also maximize opportunities for economic prosperity. Our investment in critical infrastructure goes beyond pipes, pumps and plants. Funding improvements across our service area helps ensure people and businesses thrive.

Here's what we know: Every \$1 million invested in water projects has an economic impact of 15 to 18 jobs - matching the impact of investments in clean energy, healthcare and defense. So, investing in water creates and sustains jobs, supports economic development and opens the doors of opportunity for small, local and underrepresented businesses.

The numbers in this report reflect our commitment to our contracting partners and to every underrepresented entrepreneur who has brought talent, innovation and dedication to our work. In fact, in FY 2025, our work contributed \$190 million in payments to Minority Business Enterprise (MBE) firms and \$202 million in contracts awarded to MBE firms.

Our commitment to small, local and underrepresented businesses is rooted in a simple but powerful belief: WSSC Water is an anchor institution whose work serves as a building block to uplift the communities we serve. And that's exactly what our \$271 million investment in our Piscataway Bioenergy facility did. Completed in FY 2025, this innovative project involved the participation of 34 diverse firms in design and construction. That translated to nearly 150 jobs to diverse and small/local businesses. And we surpassed our target of \$36 million, or 13.32 percent in contract awards. By the time work wrapped up, our utilization was nearly 17 percent, with more than \$41 million invested with small, local and underrepresented business partners.

In addition to celebrating our past successes, we are looking forward, recognizing that there's more work to do – especially in these uncertain times. And with your ongoing support, WSSC Water is committed in our efforts to expand opportunities, create jobs and ensure the benefits of our projects flow into our communities.

Key Report Findings

Our contract payments and awards are based on the service areas of Prince George's and Montgomery counties, as well as other surrounding areas in Maryland, Washington D.C., and out-of-state cities. Women Business Enterprise (WBE) firms are included in the MBE figures throughout the report unless otherwise noted.

MBE Program Results

Since 1978, the Office of Supplier Diversity & Inclusion (OSDI) has administered the MBE Program, and, since 2001, the SLBE Program. Both programs continue to respond to the urgent need to eliminate barriers to succeed in the public marketplace for prime contractors and subcontractors.

Contract Payments

A key performance measure of the MBE Program is the dollar value of contract payments made to MBE firms. Actual contract payments to MBE firms measure the meaningful success of the MBE Program. During the lifecycle of a contract, several variables influence the use of contractors, including change orders, contract scope changes and the availability of the proposed project team.




Figure 2: FY 2025 MBE Contract Awards

Payments by Contracting Area

In FY 2025, WSSC Water's contract payments totaled over **\$591 million**, while MBE contract payments totaled over **\$190 million**, or **32**% of all contract payments, as shown in **Figure 1**. WSSC Water's highest percentage of payments to MBE firms was in the Professional Services contracting area, as shown in **Figure 3**.





Figure 4: MBE Total Contract Payments by Classification

Figure 4 shows a breakdown of MBE contract payments by each recognized MBE classification. Women-owned firms received the largest share of MBE contract payments, with 31% of payments, followed by African American firms at 28%. Asian American firms received 21% of MBE contract payments, Hispanic American firms received 19% and Native American firms received 1%.

Figure 5 shows that WSSC Water spent **40**% with **Prince George's County** and **13**% with MBE firms in **Montgomery County**. **87**% of MBE payments were spent in the Maryland and Washington, D.C. areas.

As indicated in Figure 6, over the past five years, WSSC Water has allocated an average of 31% of its total payments to MBE firms.

MBE Contract Awards

Contract awards are a leading indicator of future contract payments. It represents upcoming contracting needs for WSSC Water and can provide a forecast of future spending. Many contracts have multi-year terms, and the impact of contract award dollars on contracting expenditures may extend beyond a single fiscal year.

WSSC Water awarded **nearly \$600 million** in contracts, with MBE contract awards totaling more than **\$202 million**, or **34**% of total contract awards, as shown in **Figure 7**. In FY 2025, WSSC Water's highest percentage of contract awards to MBE firms was in the Professional Services contracting area.

Figure 8 shows the allocation of MBE prime contracting awards and MBE subcontracting awards in each contracting area. In FY 2025, **63**% of MBE contract awards were awarded at the Prime level.




Figure 13: SLBE Contract Payments by Location

Figure 13 shows that **59**% of SLBE payments went to firms located in Prince George's County and **31**% went to firms in Montgomery County. Firms are eligible for consideration in WSSC Water's SLBE Program if the firm's principal location is in Prince George's or Montgomery Counties, or if at least **25**% of the firm's workforce resides in either county.
