UPON ARRIVAL, THE CREW FOUND MANHOLE 047M OVERFLOWING AT 3GPM, ONTO THE GRASSY AREA AROUND THE MANHOLE AND INTO A STORM DRAIN THAT OUTFALLS INTO THE PAINT BRANCH BASIN.THE CREW JETTED FROM MANHOLE 006U TO 047M, A TOTAL OF 148', AND HIT AND RELIEVED A WIPES AND ROOTS BLOCKAGE AT 108', TO END THE EVENT.
