CAUSE: WATER MAIN BREAK EST OVERFLOW VOLUME: 88 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 005M OVERFLOWING AT 1 GPM, ONTO THE STREET, AND INTO A NEARBY STORM DRAIN THAT OUTFALLS IN THE PAINT BRANCH BASIN. THE CASUE WAS DEBRIS FROM A WATERMAIN BREAK ENTERING THE SEWER MAIN. THE CREW CLEANED MANHOLE 003U AND 005M, AND REMOVED HEAVY SAND AND ROCKS, TO END THE EVENT.

ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.
