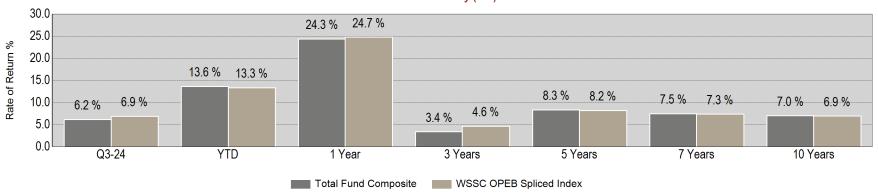

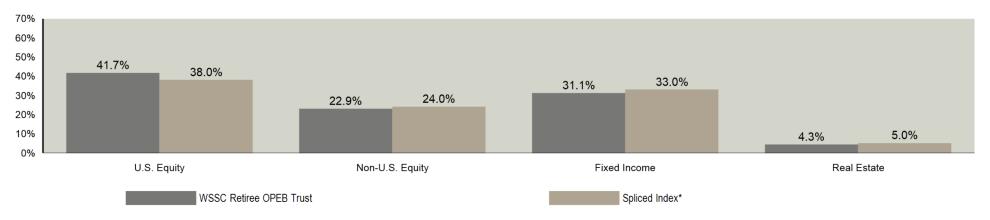

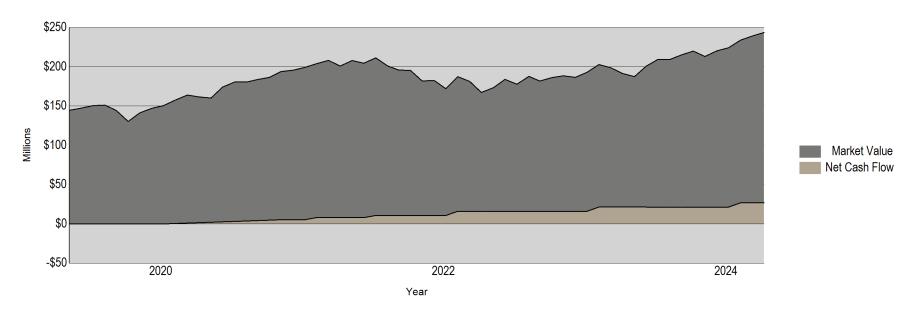

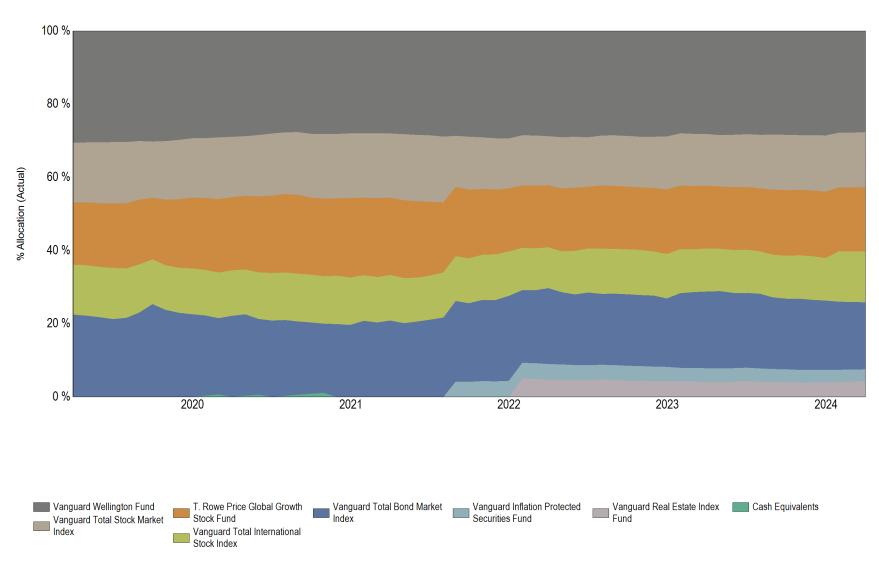

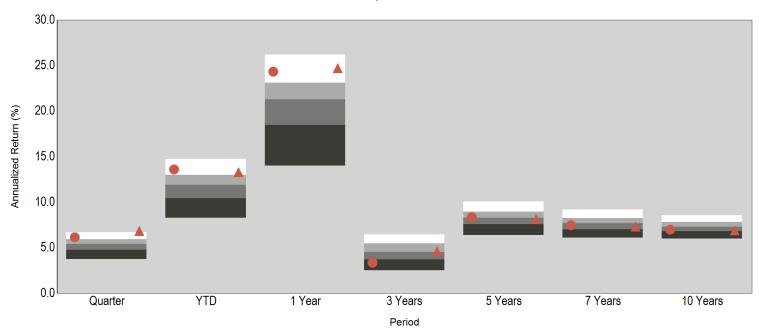
Asset Allocation History

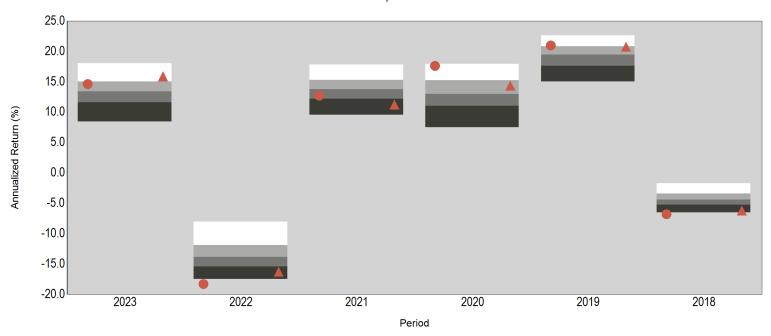

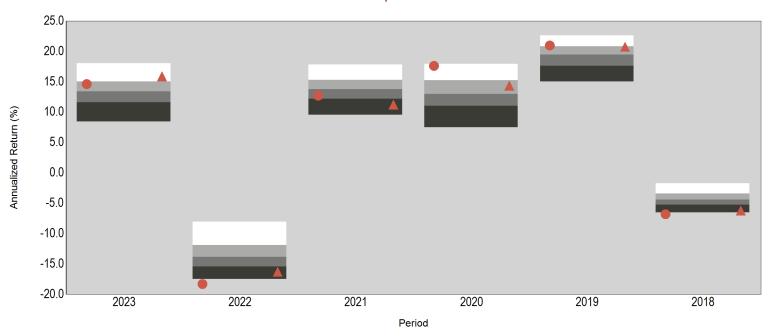
