UPON ARRIVAL, THE CREW FOUND MANHOLE 035M OVERFLOWING ONTO THE PAVEMENT AND INTO A STORM DRAIN THAT OUTFALLS INTO NORTHWEST BRANCH. THE CREW JETTED FROM MANHOLE 034U TO 035M, A TOTAL OF 294', AND HIT AND RELIEVED A GREASE BLOCKAGE AT 294', TO END THE EVENT.

IMPACTS UPON PUBLIC HEALTH AND STATE WATERS:

DRY WEATHER

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE:

THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUCTED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

FLUSHED BACK INTO MANHOLE

THE CREW WASHED DOWN THE PAVEMENT WITH DECHLORINATED WATER.
