Part A: Lobbyist Information

Section 1: Enter the full name and business address of the individual, organization, or corporation registering. The address should be one where the person can be reached throughout the year. If the business changes during the period of registration or before all required reports are submitted, an address change must be mailed to the Board.

Section 2: If you are a lobbyist and employ staff to carry out part of the lobbying activity, those individuals must submit their own registration and, in addition, be listed in this section. Additionally, if you are an employer, you must list any lobbyist you employ.

Section 3: Identify the person or organization that employs or compensates the lobbyist. Enter the complete name and business address as well as the nature of the business.

Part B: Authorization to Act (Employer Information)

Section 1: Identify the matters to which the authorization will pertain as specifically as possible. Statements such as “any and all matters” are not sufficient. Please use any available **numbers, formal designations, or other descriptive references where possible**. If the nature of the matters listed substantially changes during the authorization period, then a letter stating the change must be submitted to the Board.

Section 2: Indicate the entire period of time for which the person or organization named in PART A, Sections 1 or 2 are authorized to represent the employer.

Section 3: Enter the complete name and business address of the employer in the space provided. This should be the name of the employer, as it appears in PART A, Section 3 of the form.

Part C: Affirmation and Oath

Lobbyist signs to indicate that the information is accurate under penalties of perjury.
