WSSC'S CY 2005 Annual Ethics Report

This is WSSC's 2005 (calendar year) Annual Ethics Report required under WSSC Code of Ethics § 2-10 and Maryland Annotated Code, State Government Article, Title 15, Subtitle 8, Part III. The report covers conflicts of interest matters that were addressed by the WSSC Board of Ethics, WSSC employee financial disclosure, and lobbying registration and reporting.

The current WSSC Board of Ethics members are Debra Davis, Esquire, Chair (Prince George's County), Sharon Constantine (Montgomery County), Charles Kuderna (Prince George's County), and Warren Fleming, Alternate (Montgomery County). The Board of Ethics met fourteen times during 2005 to consider and review requests for advisory opinions, complaints, and other matters. During the year, the Board of Ethics issued six Advisory Opinions on conflict of interest topics. Attached is a summary of each Advisory Opinion. (Appendix A) There were two Complaints filed during the year on conflict of interest matters. Attached is a summary of each Complaint. (Appendix B)

Additionally, the Code of Ethics requires an individual to register as a lobbyist if they are compensated to influence executive or administrative actions by WSSC. During 2005, there were sixteen lobbyist registrations filed on behalf of twenty-four clients with the Commission. Attached is a listing of all registered lobbyists and their clients. (Appendix C). Also attached is a summary of the Lobbyist Expenditures as reported on the WSSC Lobbyist Activity Report. (Appendix D).

To improve access to Ethics information, the Board has added more content to its web site (www.wsscwater.com/ethics/index.cfm). The web site contains the Code of Ethics, lobbyist registration information, Advisory Opinions issued and the Board of Ethics Rules and Procedures.

The Code of Ethics requires certain employees to file annual financial disclosure forms. State law requires that the content of WSSC's financial disclosure regulations be "substantially similar" to the State. The Commission has initiated an on-line system for employees to file their financial disclosure forms. Approximately 450 employees filed financial disclosure forms during CY 2005.
