WSSC'S CY 2008 Annual Ethics Report

The report covers conflicts of interest matters that were addressed by the WSSC Board of Ethics, WSSC employee financial disclosure, and lobbying registration and reporting.

The current WSSC Board of Ethics members are William H. Walton, Chair (Prince George's County), Steven J. Hausman (Montgomery County), Robert J. Moore (Prince George's County), and George E. Pruden, II, Alternate Member (Prince George's County). Mr. Charles Kuderna was a member of the Board until August 2008 and then the Commissioners appointed Mr. Robert J. Moore (previous alternate) to fill Mr. Kuderna's vacant seat. Mr. George Pruden was appointed to fill the vacant alternate seat.

The Board of Ethics convened twelve times during 2008 to consider and review requests for advisory opinions, complaints, and other matters. During the year, the Board of Ethics issued six (6) Advisory Opinions on conflict of interest topics. Attached is a summary of each Advisory Opinion and Complaint (Appendix A).

Additionally, the Code of Ethics requires an individual to register as a lobbyist if they are compensated to influence executive or administrative actions by WSSC. Attached is a summary of the Lobbyist Expenditures as reported on the WSSC Lobbyist Activity Report (Appendix B).

During 2008, the following actions have been taken:

- Code of Ethics Continue to provide New Hire Code of Ethics Training
- Code of Ethics Provided Financial Disclosure/Conflict of Interest Training
- Code of Ethics Distributed Annual Payroll Stuffer to all WSSC employees
- Code of Ethics Administered Code of Ethics Training for WSSC's entire workforce
- Coordinated with the Ethics Steering Committee to hire an Ethics Officer, but at this time the WSSC has no funding for this position

To improve access to Ethics information, the Board has added the streaming notice to inform the Lobbyist of the registration fee increase to its web site (www.wsscwater.com/ethics/index.cfm). The web site contains the Code of Ethics, lobbyist registration information, Advisory Opinions issued, and the Board of Ethics Rules and Procedures.

The Code of Ethics requires certain employees to file annual financial disclosure forms. State law requires that the content of WSSC's financial disclosure regulations be "substantially similar" to the State. The Commission has an on-line system for specified employees to file their financial disclosure forms.
